## 4. SMCOG Staff Update

Aishwarya Shrestha provided a recap of the Statewide Planning Partner Meeting in Jefferson City. She provided a recap of MoDOT's 2023 year in review, safety updates for the state and SW district, and BRO and TAP updates. She mentioned that the pdf version of the meeting packet contains all the presentations provided during the meeting.

Aishwarya noted that MoDOT is seeking projects for the FY26 Transportation Alternatives Program (TAP). The deadline to apply is April 26, 4:00 pm. She also noted that any projects utilizing MoDOT Right of Way must be submitted to SW MoDOT Area Engineer, Beth Schaller, for review by April 5. If applicants would like SMCOG to provide a courtesy review, applications should be submitted by April 8. Applicants should submit a request for SMCOG letter of support by April 17.

Aishwarya highlighted the different articles in the meeting packet that might be of interest to the TAC members. Aishwarya mentioned that the May 8 TAC meeting is cancelled as it falls on Truman Day.

## 5. MoDOT Update

Frank introduced Justin Bray (MoDOT), and Dan Westkamp (FHWA). He encouraged all communities to submit a TAP application as MoDOT has extra funds from the last cycle. Frank mentioned several upcoming public meetings in the SMCOG region.

 I-44 Corridor Upgrades & Melville Bridge Project in Springfield Date: 4:30 p.m. - 6 p.m., Tuesday, March 19 Location: Crossway Baptist Church, 2900 N Barnes Ave, Springfield Project Description: This project includes lane widening, bridge replacement and interchange improvements along the I-44 Corridor in the Springfield area.

- Missouri Route 64 Bridge Replacement in Dallas County Date: 4:30 p.m. - 6 p.m., Tuesday, March 26 Location: Bennett State Park Nature Center, 26250 MO-64 ALT, Lebanon Project Description: This project replaces the Missouri Route 64 bridge in Bennette Springs.
- Greene County Route MM Realignment in Republic Date/Time: 4:30-6 p.m., Tuesday, April 2 Location: Springfield Livestock Marketing Center, 6821 W Independence Dr, Springfield Project Description: Project will improve safety and traffic flow by relocating Greene County Routes MM while building a bridge over 1 BNSF railroad in Republic.
- Missouri Route 13, U.S. Route 160 and Missouri Route 248 Roundabout north of Reeds Spring

Date/Time: 4:30-6 p.m., Tuesday, April 9 Location: District Learning Center, Reeds Spring High School, 20277 MO-413, Reeds Spring Project Description: This project will improve the intersection of U.S. Route 160, Missouri Route 13, Missouri Route 248 and Dogwood Tree Road north of Reeds Spring.

 U.S. Route 60 Intersection Improvements in Seymour Date/Time: 4:30-6 p.m., Monday, May 13 Location: Seymour Middle School Cafeteria, 501 E Clinton Ave, Seymour Project Description: This project will build a new interchange at U.S. Route 60 and Webster County Route C/K intersection and intersection Improvements at Route 60 and Clinton Avenue in Seymour.

## 6. MPO Update

David Knaut mentioned OTO submitted a RAISE grant for Hwy MM corridor between I-44 & Hwy 60. OTO announced call for projects for TAP engineering. TAP Call for Projects for all will be announced in July.

## 7. Legislative Reports

Mike Ussery mentioned that the Senate hasn't voted on the FAA Authorization yet. They will need to vote by May 10. A funding resolution was passed last week, Senator Schmidt voted no, and they have till March 27 to resolve. Schmidt will vote no on any resolution as he wants to see the appropriations reviewed singularly, not as a large group, this has not been done since the 1990s.
