Open Meeting

Approval of June 24, 2009 Agenda

Legislative/Partner Agency Reports:

Stacy Burks, Senator Bond's Office: (Do not have report due to malfunction of tape recorder).

Steve McIntosh, Congressman Blunt's Office

Transportation is a major issue in each county. Financing is a major issue. Health Care reform may be falling apart this year. Congressman Blunt led the task force on health care reform this year. The question of how to lower health care is being addressed. The House takes up the Homeland Security Bill. Defense authorization act

David Rauch, Senator McCaskill's Office

Appropriations process is starting. Highway discussion on the House side is looking at a \$500 million package with \$50 million going to high speed rail. This is a long way from resolution. \$3.65 billion has been identified for sewer, drinking water etc. Would be a 119% increase over '09 funding. Health Care and Cap and Trade are the big issues facing Congress right now. Senator McCaskill is chairman on contracting oversight. SEMA is hosting meetings throughout the area on disaster declarations.

Valerie Robinson, MoDNR

There is a big transition at the agency. This is moving slowly. New budget starts in July. DNR hopes to continue the Ombudsman Program. There is a renewed emphasis on working at the lakes with inspections and working on water quality. There is discussion occurring about septic tanks.

Dawne Gardner, MoDOT District 8

Diverging diamond is now open at Kansas Expressway and I44 interchange. Some work remains but will be completed by July 7th for the official opening. This is the first one in the U.S. This project design saved considerable money versus a traditional design fix. ARRA projects are moving ahead on schedule.

Eric Kellstadt, MoDOT District 7

Slow time of year for lettings for District 7. Route 60 project should start construction by mid-July.

Tim Conklin, Ozark Transportation Organization:

STP urban funding recipients are making their deadlines. OTO is working with City Utilities on a working group for transit lines and whether they can be modified to increase efficiencies. OTO is working with MoDOT on ride-share issues.

Ronda Headland, Missouri Department of Conservation:

National Wetlands plan is currently being updated. Last plan in Missouri was completed in 1989. Missouri is often the model for wetland management. Fishery personnel are working on national fish habitat partnership initiatives. Hopefully this will result in increased federal funding.

Most of the expenses are obligated with a balance of around \$40,000. For 2008 we have the paperwork and everything signed we are now waiting for an account number. We will be purchasing more items but it will be for a less amount. The 2009 money has been approved for Missouri. We are receiving \$11,272,000. The October RHSOC meeting is now going to be a large event that will be held at the fairgrounds. Purchased equipment will be showcased. It will be an all day event.

Economic Development/Interim Director Report, Jane Hood

Public Officials/Elected Officials workshop training is scheduled for July 30th from 5-9 at the library center. Richard Sheets from the Missouri Municipal League will be speaking. This is training for anyone involved with municipal government. We are partnering with MU Extension. A date has been set for August the 18th for a workshop on economic development. Know Your Region will be the topic. Sharon Gulick with the University of Missouri will be putting this program together.
