Regional Transportation Needs Prioritization- SMCOG –Megan Clark

a. Bicycle/Pedestrian

The top ten SMCOG region bicycle and pedestrian needs were presented by staff and discussed by members of the TAC. Members voted and ranked the top ten projects for the SMCOG region.

Motion to rank complete street improvements on Main Street in Mount Vernon as priority number one made by Mike Randall, seconded by Dennis Pyle. Motion carried.

Motion to rank the addition of sidewalks on at least one side of Rte. 125 in Fair Grove as priority number two made by Rick Davis seconded by Max Springer. Motion carried.

Motion to rank the addition of a pedestrian crossing on Rte. 125 at the Chadwick School as priority number three made by Todd Wiesehan, seconded by Buddy Roberts. Motion carried.

Motion to rank the addition of sidewalks to at least one side of the street along PP/F in Fordland as priority number four made by Harlan Hill, seconded by Dennis Pyle. Motion carried.

Motion to rank the addition of sidewalks on at least the east side of Route 13 in Kimberling City as priority number five made by Mike Randall, seconded by Max Springer. Motion carried.

Motion to rank the addition of sidewalks on Route 32 in Buffalo and the addition of a pedestrian crossing at Locust Street as priority number six made by Dennis Pyle, seconded by Buddy Roberts. Motion carried.

Motion to rank the addition of sidewalks along Business 65 and lighting at intersections in Hollister as priority number seven made by David Miller, seconded by Max Springer. Motion carried.

Motion to rank the addition of pedestrian accommodations on the bridge on Rte. 112 over the Dry Hollar Branch at Roaring River State Park as priority number eight made by Mike Randall, seconded by Dennis Pyle. Motion carried.

Motion to rank the addition of shoulders on Route 160 in Dade County as priority number nine made by Max Springer, seconded by Todd Wiesehan. Motion carried.

The remaining item of signage for bike routes along Route F in Polk County was ranked as the number ten priority.

3. MoDOT Update – Frank Miller, MoDOT SW District

Frank Miller thanked the group for their work in prioritizing regional transportation needs. He stated that funding projections are up a little, so there may be some limited funds for projects. The list of priorities could also be used for ADA plan updates and improvements or safety plan projects.

Travis Koestner was introduced as the new MoDOT Southwest District Engineer. Mr. Koestner offered to meet with any person interested or come to County meetings, just contact his office.

Beth Schaller was introduced as the area engineer for the entire SMOG region. Previously, all four area engineers covered the SMOG region, but the coverage areas have been updated as to align with the regional planning commission boundaries.

Beth Schaller reported that there will be bridge re-decking on I-44 at Mt. Vernon from mid-February through the summer. Alternate routes and detours will be posted.
